

Patriot James Noble Moberly, Missouri 1759-1845

James Noble assisted in establishing American Independence as a Private, Virginia Continental Line. He enlisted in early 1777 and served in Captain Lord's Company, Colonel Stephen's Regiment; in Captain McLean's Company of Spies, Colonel Febiger's Regiment; and in Captain Shelton's Company, General Wayne's Regiment. He was at the Battle of Monmouth and Battle of Stony Points, and wounded at the Battle of Germantown. His service is



documented in his pension application S16991 at the U.S. National Archives & Records Administration. He received a pension starting 29 January 1834 for his service.

James (son of Mark Noble and Elizabeth Hepborn) was born December 1759, Kent County, Maryland; died 1845, Randolph County, Missouri; and buried Sugar Creek Cemetery, Moberly, Randolph County, Missouri. James first married Mary West on 12 December 1780, Hartford, Maryland. Mary was born 1765, Hartford, Maryland; and died 1818, Kentucky. Children:

- Thomas Noble (1783-1821). Thomas married Mary Polly Brinton.
- Mark Noble (1785-1870). Mark married Rachel Crouch.
- Elizabeth Noble (1788-1822).
- Paulina Noble (1809-1842). Paulina married Robert Shaw.

James second married Cytha in 1830, Howard County, Missouri.

Sugar Creek Cemetery is located on Highway DD, Moberly, Randolph County, Missouri at coordinates: N39° 26' 48.84" and W94° 27' 18.00". He has a recently replaced military headstone and memorial marker placed by the DAR Howard County and DAR Margaret Miller Chapters.
